Practice-based expertise in at least one of the areas would also be an asset. The successful candidate will be expected to teach in the LLB Undergraduate programme and to make a full contribution to the Faculty of Law's research profile and academic administration.

Excellent communication and interpersonal skills are essential, as is a strong commitment to excellence in teaching, scholarship, service and technology application in the classroom.
