PRIOR LEARNING ASSESSMENT

Overview

- 1. Assessment of prior learning is based on the principle that skills, knowledge and understanding gained outside formal education or training should be recognised. This recognition suggests that evidence of learning is of primary importance and this is not only characterised by some form of certification.
- 2. In assessing prior learning the individual being assessed must present evidence of his/her learning. For the Postgraduate Certificate in University Teaching and Learning, this evidence can take a variety of forms such as:
 - A learning log or journal that shows evidence of growth and development as a teacher including examples of strategies used and results obtained.
 - Products of workshops aimed at developing knowledge, skills and attitudes and evidence of skills/competencies. These may include collections of items in a scrapbook or portfolio, CDs, DVDs, videos of relevant performances.
 - Records and samples of work done based on readings and application of principles and practices identified.
 - References from relevant professionals who support claims of skill mastery within the appropriate context.
 - Performance/assessment reports.
 - Prior teaching certification.

Who Assesses?

3. Assessment of evidence provided should be done by a panel guided by the head of the Instructional Development Unit using a framework of standards that devolve from the learning outcomes of the courses within the Postgraduate Certificate in University Teaching and Learning.

How the Assessment of Prior Learning Will Be Implemented

- 4. This form of assessment is implemented by review of evidence of achievement that is weighed against an identified standard and about which some decision is made. The identified standard will be as defined by the learning outcomes of the relevant courses, from which an appropriate rubric has been constructed.
- 5. The following are possible outcomes of a review of evidence:
 - Award of some or all course/courses credits.
 - If all course/programme credits awarded, then the awardee gains exemption from the course/courses and no further work is required.
 - If more than half the course credits have been awarded then specific completion task(s) may be assigned to earn the outstanding credits.
 - If less than half the course credits have been awarded the course must be completed in its entirety.
