## Primary Health Care: Current and Future Models for the Caribbean

Thus, this conference represents an opportunity to further the dialogue on some of these issues and should be viewed as a tangible milestone that supports the collective vision and health agenda of the region, by providing a platform for the distillation of evidence that can contribute to health systems strengthening as well as to our understanding of the implementation constraints, governance, financial and delivery arrangements for primary care, public health and wellness services in the Caribbean. It is envisaged that arising from the deliberations at this conference there will be evidence that can be packaged and incorporated into health and social policies that benefit the peoples of the region.

This year's conference will also feature the launch of CARPHA Clinical Care Guidelines as well as plenary talks on Cancer, Non-communicable Diseases and Capacity Building. Once again, on behalf of the Planning committee, we welcome you as well as our various sponsors to our conference and wish that you will have a productive and rewarding experience.
