Consequently, four compounds were obtained from Streptomyces sp CSDX076 for the first time and identified as aurantiamide benzoate, deoxytryptoquivaline, 2-acetyl-3,5-dihydroxyl-benzene acetic acid, and 2-acetyl-3,5-dihydroxyl-benzene ester.

In the sample population, 76.9% of the patients had chronic kidney disease stage III, 7.7% were in stage IV and 15.4% in stage V. There were 3.1% of patients with persistent proteinuria. Hypertension and diabetes mellitus were co-morbidities.
