On **April 6, 2017** MonaLaw Year 1 students held a Public Debate under the Moot: “*Be it resolved that the Jamaican Courts should follow the Supreme Court of Canada’s decision in Bhasin v Hrynew and adopt the doctrine of good faith as a fundamental organizing principle of contract law*”. Ms Ruth-Ann Benguche, Ms Andrea Linton and Mr Micheal Warenycia supported the proposition, while Ms Samantha Grant, Mr Theodore Duncan and Ms Ceejaie Cummings opposed it. This debate sought to lay the foundation as to whether there is a proper basis on

which the Jamaican courts could justify adoption of good faith as a fundamental organizing principle of contract law and whether contracting parties have a duty of honest performances in their dealings. The commitment of these students’ and the quality of their output have been highly commended, including by then Chief Justice, The Hon. Mrs Justice Zaila McCalla; President of the Court of Appeal, The Hon. Mr Justice C. Dennis Morrison; and Chairman of the General Legal Council, Mr Allan Wood, QC.

## ABOLITION OF THE DEATH PENALTY



The presentations were delivered by Mr Mark Pritchard, MP, who is the Joint Chairman of the UK All Party Parliamentary Group on the Abolition of the Death Penalty and Vice Chairman of the All Party Parliamentary Group for the Caribbean and Madam Michèle Duvivier Pierre-Louis, who is a Haitian national, the Commissioner for the International Commission Against the Death Penalty, and most notably, a Former Prime Minister of Haiti.

They presented arguments on the abolition of the death penalty and called upon Jamaica to do away with capital punishment.

## LET'S TALK ABOUT VIOLENCE AGAINST WOMEN

**‘Let's Talk: A Seminar on Violence Against Women’**, was born out of a conversation I had with a friend. We were discussing the spate of violent attacks on females on the campus at the time, as well as in the country more generally. I have always wanted to do something that advances the welfare of females. In that conversation, I asked quite rhetorically, "Why doesn't the Principal do anything about it (violence against women on campus)". I then realized that action need not come from behind a desk, you just have to be willing to do something, anything.

The seminar was held on **February 24, 2017** and the presenters were Mr Terrence Williams, Commissioner of INDECOM; Mr Kevon Stephenson, Director of Evaluation and Standards at INDECOM; Ms Nadeen Spence, Student Services and Development Manager for Mary Seacole Hall, The UWI, Mona and a firm advocate for the empowerment of women and girls; and Dr Gillian

Mason, Lecturer in the Department of Sociology, Psychology and Social Work at The UWI, Mona and a board member of Woman Inc. The seminar focused on improving reporting mechanisms and the importance of treating women and girls who have experienced gender based violence with humanity and respect so that they do not suffer in silence because they are afraid of being ridiculed. Commissioner Williams, indicated that the research his office undertook in preparation for the seminar will form part of his Office's quarterly report to Parliament as well as his own recommendations. He admitted that until the seminar, he had not realized how much issues of gender based violence related to his Office.

I thank my mentors for giving me the courage and confidence to conduct the seminar, and the administrative staff for their unwavering support in staging the event.

## ADVOCATING FOR THE RIGHT TO THE TRUTH AND SOCIAL JUSTICE

In **May 2017**, MonaLaw hosted a conversation with two accomplished Jamaican sisters who live and work in the UK, civil rights lawyer, **Marcia Willis Stewart** and violence against women expert and advocate, **Marai Larasi**. Both spoke about their careers as advocates for social justice and their relationship with Jamaica.



**Marcia Willis Stewart, QC**, the big sister, is an award-winning civil rights lawyer and a partner at the renowned Birnberg Peirce & Partners law firm. She was the lead lawyer for the legal team acting on behalf of 77 of the 96 families of the deceased at the Hillsborough Inquests, and helped to secure justice when it was ruled that the 96 victims were unlawfully killed. She was awarded Legal Aid Practitioners' Group Public Law Solicitor of the Year 2015. In 2016, the Black Solicitors Network named her Outstanding Lawyer of the Year 2016 in their UK Diversity Legal Awards. She was a joint winner of the prestigious Rule of Law Award at the Halsbury Awards 2017. She has also been given the Football Black List 2017 Commercial Award, listed in The Lawyer Hot 100 2017 and named Legal Personality of the Year at the Solicitors Journal Awards 2017. Willis Stewart was also made an honorary Queen's Counsel in 2017.



**Marai Larasi** is the Director of Imkaan which is an UK-based national organization dedicated to challenging violence against black, minorities and refugee women and girls. She led the development of the first service within a London-based VAWG organisation to develop provision aimed at responding to women affected by both VAWG and Serious Youth Violence. Larasi is also the Co-Chair of the country-wide End Violence against Women Coalition. She was also the Joint Chair of Women's Aid, England until September 2013. She is a member of the Mayor of London's VAWG Panel. She is a founding member and committee member of the board of the Global Network of Women's Shelters (GNWS) and a founding member of the International Network to End Violence Against Women. She was also a panel Member for the Office of the Children's Commissioner's Inquiry into Child Sexual Exploitation in Gangs and Groups. In 2011 she was voted 1 of the 50 most influential women in London in the last 100 years and in 2013 she was awarded the MBE Member of the Most Excellent Order of the British Empire.

On **June 9 to 11, 2017**, the Faculty of Law on the Mona Campus of The University of the West Indies hosted its **3<sup>rd</sup> Annual Weekend Symposium on Law, Governance and Society** at **Meliã Braco Village, Trelawny**. The focus for this year was **“Security and Justice: Global Priorities”**. The sub-themes for the Symposium included financial crime, money laundering and the legal profession, sports law, internet law, individual rights and alternative dispute resolution/restorative justice.

The Keynote Address was delivered by Professor Barry Rider OBE LLD, Professorial Fellow at the Centre for Development Studies at Jesus College, Cambridge, UK. The focus of this address was on

strategies for fighting economic crime. The Panel Chairs comprised the following: Mr Allan Wood, Chairman of the General Legal Council of Jamaica; The Hon. Madame Justice Désirée Bernard, retired Judge of the Caribbean Court of Justice; Professor Trevor Munroe, Executive Director of the National Integrity Action (NIA); The Hon. Mr Justice Seymour Panton, Judge of the Mechanism for International Criminal Tribunals (MICT) and former President of the Court of Appeal of Jamaica; Mr Alexander Williams, Chairman of the Jamaica Anti-Doping Commission (JADCO) and The Hon. Mr. Justice C. Dennis Morrison, President of the Court of Appeal of Jamaica.

The consistent responses from participants indicate that the event featured very distinguished panellists, whose presentations were not only thought-provoking but enlightening and instructive. For example, the session entitled ***'Clean Lawyer: Dirty Money'*** explored the circumstances in which attorneys may become embroiled in a money laundering transaction, as well as the international and local machinery for preventing and detecting money laundering through the legal profession. This was timely in light of current litigation in Jamaica concerning the application of certain provisions in the Proceeds of Crime Act (POCA) to lawyers.

This session featured Mr Calvin Wilson, Executive Director of the Caribbean Financial Action Task Force on Money Laundering (CFATF); Mr Andrew Mitchell QC, Barrister-at-Law in the United Kingdom; The Hon. Mr Justice Bryan Sykes, then Puisne Judge in the Supreme Court of Jamaica; and Mrs Caroline Hay, Attorney-at-Law and former Senior Deputy Director of Public Prosecutions, Jamaica. The session was chaired by Mr Allan Wood QC, Chairman of the General Legal Council of Jamaica.

The session on ***'Securing Individual Rights'*** examined the issue of marriage rights from a secular and religious perspective, as well as the area of freedom of expression in the context of the internet. The latter topic was addressed by Ms Dionne Jackson-Miller, Attorney-at-Law, Host of All Angles on Television Jamaica (TVJ) and Adjunct Tutor at MonaLaw.

In ***'Security in a Changing World'*** Professor Anthony Clayton of the UWI Institute for Sustainable Development took an in-depth examination of the crime and terrorism threat in Jamaica and a comparative approach with Brazil on possible approaches to dealing with this menace.

Mr Terrence Williams, Commissioner of the Independent Commission of Investigations (INDECOM) looked at crime from the victim's perspective, specifically with regard to opportunities for private prosecution and obtaining a remedy for victims. *'In the Alternative'* was a session that focused on the spectrum of mechanisms available to resolve contentious matters beyond the mainstream solutions, including mediation, arbitration and restorative justice. Mrs Campbell-Daenen, who is an MPhil student at MonaLaw, examined the rights of migrant persons.

## BOOK DONATIONS

The Canadian government-funded, **Improved Access to Justice in the Caribbean (IMPACT Justice) Project** donated **£80,000** worth of books to The University of the West Indies, Mona Library. The Handing-Over Ceremony took place on **Thursday, September 8, 2016**.

Professor Velma Newton Officer-in-Charge of the Caribbean Law Institute Centre (CLIC) and Regional Director of the IMPACT Justice Project opened the programme, and His Excellency Sylvain Fabi, High Commissioner of Canada to Jamaica addressed the gathering on behalf of the Canadian Government. Also in attendance were representatives from the Canadian Government, the High Commission of Canada in Barbados, the Jamaican Ministry of Foreign Affairs, and the University community. Dr Paulette Kerr, Campus Librarian; Ms Myrna Douglas, Head, Law Branch Library; and Dr Leighton Jackson, Dean of the Faculty of Law, received the books on behalf of The UWI.

The **World Intellectual Property Organisation (WIPO)**, with whom the Faculty is cooperating to offer the LLM Intellectual Property in the Creative and Cultural Industries, has donated Sixty-Nine (69) books with a declared value of over **USD 10,337.27** (roughly over **1.3 million Jamaican dollars**) to supplement the programme. On **Friday March 10, 2017**, MonaLaw competed in the Caribbean Court of Justice's Annual International Law Moot Competition in Port-of-Spain, Trinidad. Teams from every law school in the English-speaking Caribbean Commonwealth, both vocational and academic, competed: University of the West Indies (Mona), The University of the West Indies (St Augustine), The University of the West Indies (Cave Hill), University of Guyana, University of Technology (Jamaica), Hugh Wooding Law School (Trinidad & Tobago), Eugene Dupuch Law School (The Bahamas) and the Norman Manley Law School (Jamaica).

The Mona Law team comprised Mr Benjamin Fraser (advocate), Mr Tahir Thompson (advocate), and Mr Shajoe Lake (alternate/researcher). The team was coached by myself and Dr Jason Haynes. The advocates from MonaLaw were both in their first year of the LLB programme at the time, and grappled with extremely complex issues in public international law and Caribbean integration law. The selection was purposefully done, as to demonstrate the importance of advocacy as its own skill and art. In

honing that skill, the team endured several grueling practice rounds with coaches and on occasions, MonaLaw Dean, Dr Leighton Jackson. The team also faced a practice round before a panel of UK and Canadian barristers while in Trinidad (Mr Matthew Gayle, Mr Bryan McCutcheon and myself, at the offices of the prestigious J.D. Sellier & Co. in Port-of-Spain).

On the day of the competition, our team mooted first, against an all third year team from St. Augustine. The team mooted before a panel consisting exclusively of sitting judges of the Caribbean Court of Justice. Despite such tremendous pressure, and odds, the team emerged victorious (and set the tone for the day). Kudos to them! They are a shining example of the talent and potential that lies in all of our students here at Mona Law. The institutional and administrative support of Dean Jackson, Mrs Peta-Gaye McEwan-Lewis and Ms Marjorie Henry are also gratefully acknowledged.





