



MonaLaw participated in the Annual Inter-American Commission on Human Rights (IACHR) Moot Court Competition held at the Washington Cloege of Law in March 2018. While the team did not progress beyond the first round, the team found the experience to be helpful in enhancing their research and public speaking skills. It also helped to expand their knowledge on genderbased violence.

The Sixth Annual Americas Regional Round of the Price Media Law Moot Programme was hosted in partnership with the Center for Global Communication Studies at the Annenberg School, University of Pennsylvania. This took place February 1 to 4, 2018 at Benjamin N. Cardozo School of Law in New York. Of the 44 teams representing schools from the Americas, MonaLaw was ranked in the top 6 schools to advance to the International rounds at Oxford, England in April 2018.

### **Debating Triumph**

Ackeem Clarke, a second year student at the Faculty of Law, participated in a one-week debate exchange programme in Georgia, USA as a member of team from the Jamaican Association for Debating and Empowerment (JADE). As part of this one-week debate exchange, Ackeem participated in two (2) major public debates alongside teams from iDebate Rwanda, University of West Georgia, and Morehouse College. The public debate hosted by the University of West Georgia examined the appropriateness of people within the African diaspora appropriating cultural norms from continental Africa.

Through the debate exchange, students gained an immense value through exposure to different cultures. For example, they shared in a presentation by the Rwandans on the 1994 Rwandan Genocide and considered the intersectionality of that legacy to contemporary challenges confronting the Jamaican, Rwandan and American societies. Ackeem also received the award for Breakout Debater of the Year (2017-2018) at the JADE Awards 2018.





In 2011, a merger took place between Digicel Jamaica Limited (Digicel) and Oceanic Digital Jamaica Limited (Claro) that was approved by the relevant Minister under the Telecommunications Act, 2000. In 2012, the Fair Trading Commission (FTC) went to court to enforce its findings that the merger was likely to substantially lessen competition in several telecommunications markets. Digicel and Claro argued that FTC had no jurisdiction to investigate their merger. The Supreme Court rejected those arguments and ruled that the FTC has jurisdiction in telecommunications industry generally and also in regard to the particular transaction.

Digicel and Claro appealed to the Court of Appeal and in 2014, the Court of Appeal upheld the decision of the Supreme Court that the FTC has jurisdiction in the telecommunications industry, but rejected the FTC's argument that it had jurisdiction over the particular transaction approved by the relevant Minister under the Telecommuncations Act, 2000.

The FTC subsequently appealed to the Privy Council. Dr Delroy S. Beckford, Adjunct Lecturer at MonaLaw was Lead Counsel for FTC. The Privy Council held that the FTC has jurisdiction to intervene in the telecommunications market and the same was as in any other market and FTC's jurisdiction was not affected by prior approval from the relevant Minister.




