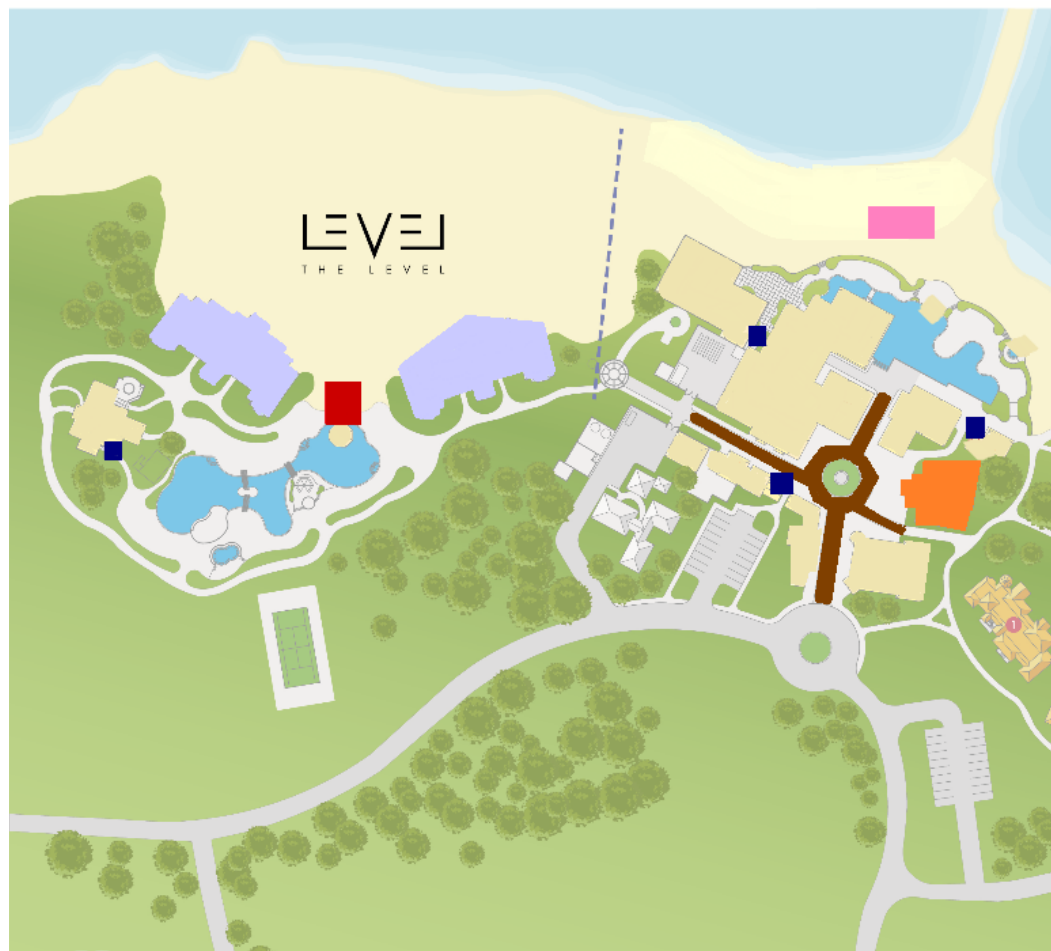
Congratulations to the Faculty of Law for hosting another important symposium and my sincere thanks to each of you for taking the time out to engage in this important discussion.

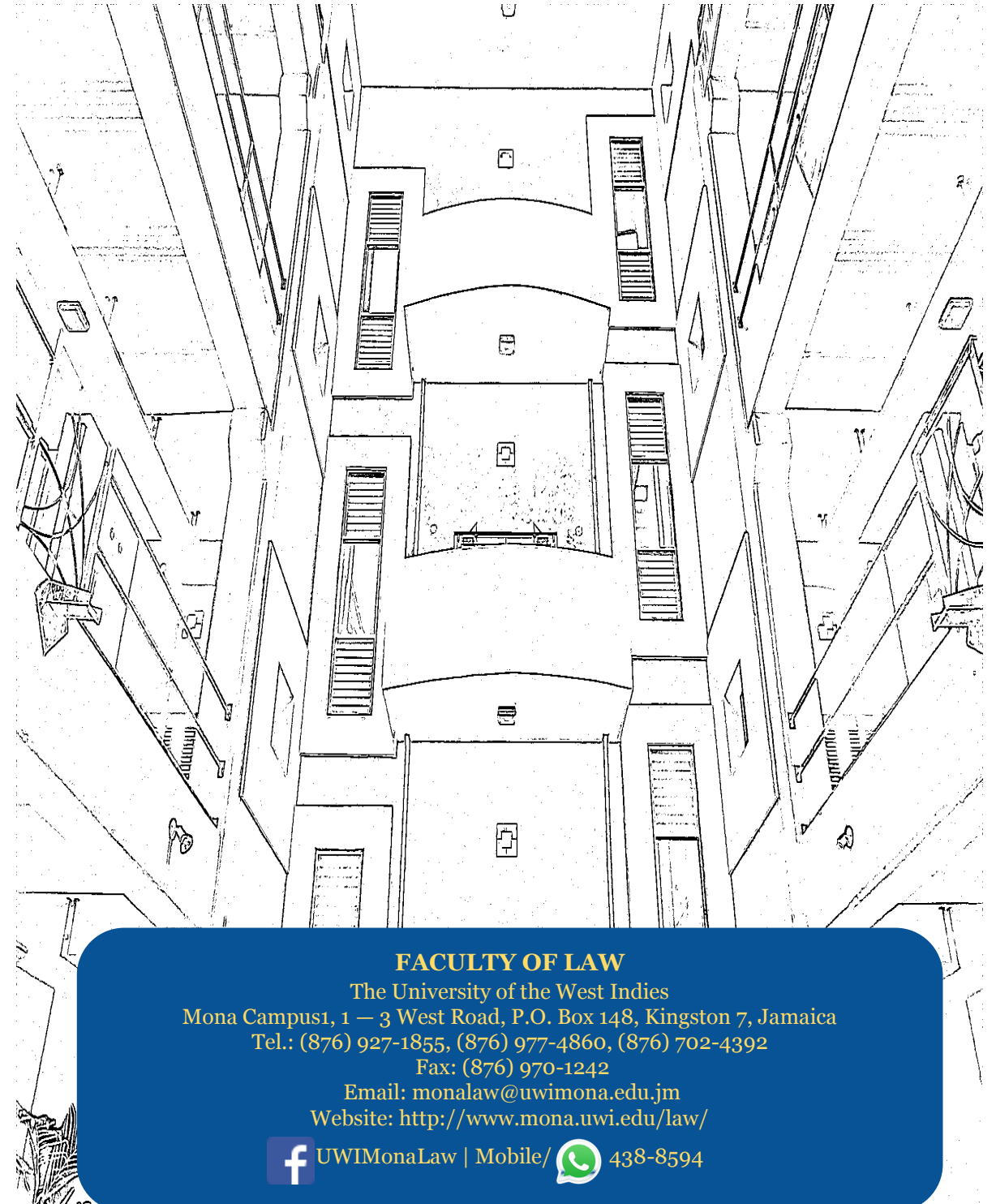
