- Currently, all MSBM graduate programmes are delivered face to face, except the MSc Marketing and Data Analytics AND MSc National Security and Strategic Studies which are delivered in a blended mode.

APPLICATIONS

What are the general entry requirements for my programme of interest?

- General entry requirements for all graduate programmes are: a bachelor's degree with GPA of 2.5 or higher. Applicants with a GPA of lower than 2.5 will be considered if they have at least 2 years working experience (except for the MBA which requires 3 years post graduate) in a related field and professional qualification/certification; and if the applicant is successful at an interview conducted by MSBM. What does 3 years post graduate work experience mean as it relates to the MBA programme?

- Applicant must have 3 years work experience **after** completing a first degree.

If I do not have a first degree, but have extensive working experience, can I be considered for a programme?

- Yes, your resume would be reviewed and you will be considered for an interview.

What supporting documents do I need to submit?

1. UWI Graduates

- Two (2) Referee's reports
- Resume

2. Non-UWI Graduates

- Two (2) referee's reports
- Resume
- Transcript
- Birth Certificate and
- Marriage Certificate (where applicable)

How do I submit documents?

- All documents except the transcript are to be sent via email to postgrad@uwimona.edu.jm and copied to msbm-gradapplications@uwimona.edu.jm

How to send transcripts:

1. Transcripts may be sent directly from your institution via email to mona-postgrad@uwi.edu and copied to mona-msbm-gradapplications@uwi.edu **OR**
2. They may also be hand delivered under confidential cover to the Office of Graduate Studies and Research, UWI Mona or to the main office at MSBM North.

How long will it take for my application to be processed?

- Application processing only begins when all the required supporting documents are submitted. Processing time takes approximately 3 weeks. ***Please note that the processing time may be longer based on the volume of applications.***

Will I have to do an interview and if yes, why?

- Not all applicants are interviewed. However, as part of the selection process, MSBM reserves the right to interview any applicant for further exploration of their qualifications and experience. You may be called for an interview, possibly at short notice, in order to expedite the process.

How will I be notified if I am not accepted?

- Applicants who are not accepted will get a letter indicating the decision.

Having been accepted, if I am unable to take up the offer, how do I proceed?

- Address a letter to the Office of Graduate Studies and Research requesting a deferral.
