# **OVERVIEW**

#### Mission of the Department

"To provide the highest standard of teaching and research to produce library and information professionals, well equipped to face the challenges of the dynamic information environment, and to provide leadership in managing the information needs of the Caribbean for the twenty-first century and beyond."

### INTRODUCTION

The Department continues to be the regional leader in the education of students in Information Studies who will become skilled, effective, responsible information users and providers and managers for various kinds of information units. The UWI Strategic Plan 2022-2027 that rests upon the three primary pillars: Access, Alignment, and Agility (Triple A) has been used as the guiding framework to plan and execute our activities. Our continued online delivery of programmes has provided access to students beyond the Caribbean borders. Our recent discussions with information professionals at the Go|School of Information in The Netherlands, and the University of Glasgow in Scotland, as well as our continued partnership activities with UNESCO, are alignments capable of achieving greater activism and public advocacy while fostering agility that will bring some level of financial health to the Department.

#### **INCOME GENERATION**

The DLIS is exploring several entrepreneurial opportunities that will provide additional streams for income generation. These include joint workshops, training seminars, lecturer-exchanges, as well as consultancies. These opportunities, it is anticipated, will provide:

- Extra income from extra-curricular activities
- Deeper relationships with the Alumni
- More international exposure
- Greater experience with entrepreneurial activities

Discussions regarding the likely income generating project with the Go|-School of Information Studies, Netherlands, are ongoing. This project includes conducting a programme of skill enhancing courses for Information Studies professionals with a world-wide English speaking target audience. These are mainly three-day workshops and a Summer Institute in 2022/2023.

#### **Academic Accreditation**

The department was forced to put its pursuance of CILIP accreditation on hold in order to include the proposed postgraduate diplomas. Based on feedback from the graduate sub-committee, the department is currently engaged in a curriculum development exercise which will see to the updating of most of its courses. It is hoped that the post graduate diplomas will then meet the required approvals. As soon as this is done, we will continue with the push towards CILIP accreditation. In the meantime four options, each consisting of three courses, are being offered to persons who are desirous of admission as Specially Admitted students. Such students will then have the option of continuing into one of the established graduate programmes, completing with either a post graduate diploma or a Master's Degree.

# TEACHING & LEARNING: GRADUATE & RESEARCH MATTERS

Semester 3 (Summer Term) 2021/2022

The DLIS is offering three courses in Semester 3, namely:

- 1. LIBS6504 Integrated Library Systems
- 2. LIBS6202 Subject Analysis and Indexing in Information Retrieval
- 3. MGMT6015 Basic Statistics (adopted from Department of Management Studies)

These are intensive courses offered over a six week period. The Department will offer all three courses online during Summer 2021/2022.

Re-Appointment: Honorary Fellow, Information Studies

The Vice Chancellor approved the re-appointment of Professor Emerita Jeannette Bastian, Simmons University, Boston, Massachusetts, as Honorary Fellow, Information Studies, to the Department for the period of September 1, 2022 to August 30, 2024. Prof. Bastian is supervising the first cohort of candidates in the MPhil and PhD programmes. She will also assist the Department in building its research capacity and developing the departmental infrastructure for the research degree programmes.

#### **Museum Studies**

The Department participated in a University-wide discussion on the development of Museology/Museum Studies in the University. The Department already had visions for developing programmes in this disciplinary area, and has courses and subject-matter content already on offer in the BA Information Studies programme. Since the purview of the Department is to teach disciplinary competencies and professional skills, steps are already afoot to offer postgraduate diploma and master's degree programmes in Museum Informatics and Management, in keeping with the Department's strategic vision. It is anticipated that these programmes will be ready for offering in 2022-2023.

#### **Postgraduate Diplomas in Information Studies**

In an effort to increase access to our programmes, in keeping with international (Commonwealth) programmatic expectations, and in response to the changing demands in professionalism and workplaces (around the Caribbean region), the Department explored the possibilities of offering Postgraduate Diplomas in Information Studies. The Postgraduate Diploma (Library Studies) was the first graduate programme offered by the Department in 1973 and was replaced by the Master of Library Studies in 1989. The Department is now proposing to offer a suite of Postgraduate Diplomas in Information Studies intended to provide training in the specific disciplines or interdisciplinary competencies of Information Studies. Programmes are designed to be offered over three (3) semesters, using courses already on offer as part of the masters' degrees in Library and Information Studies and Archives and Records Management.

In response to an online survey conducted in April 2021, over 120 respondents supported the Department's move to reintroduce the postgraduate diploma degree. Seven (7) postgraduate diploma programmes, divided

into two (2) categories, were proposed:

#### **Disciplinary Postgraduate Diploma Programmes:**

- 1. Media & Information Literacy: offers the fundamentals and principles for identifying, instructing and empowering communities, to critically evaluate their content, and to make informed decisions as users and producers of information and media content.
- 2. Library Management: offers the fundamentals and principles for managing materials, resources and services for libraries and information centres.
- 3. Archives Administration: offers the fundamentals and principles for identifying, processing and preserving archival materials and managing archival services.
- 4. Information Governance: offers principles and strategies for a holistic approach to managing corporate information and records.
- 5. Museum Informatics and Management: "Museum informatics is the study of the socio-technical interactions that take place at the intersection of people, information, and technology in museums." This programme focuses on the various modes, principles and best practices for appraising, preserving and managing art and objects in galleries and museums.

#### **Interdisciplinary Postgraduate Diploma Programmes:**

- 1. Information Organization: focuses on the various modes, principles and best practices for cataloguing information assets, from digital materials, archival documentation, active records, audiovisual recordings, and three-dimensional objects, which are traditionally offered in separate archives and records management, library and museum courses.
- 2. Information Preservation: focuses on the various modes, principles and best practices for preserving information assets, from digital materials, archival documentation, active records, audiovisual recordings, and three dimensional objects, which are traditionally offered in separate archives and records management, library and museum courses.
- 3. Digital Informatics: focuses on the various modes, principles and best practices for creating, managing information and information products in digital formats.

According to survey responses, the more popular choices were the Interdisciplinary Postgraduate Diploma Programmes and this hints at the possibility of the Department offering two new Masters' degrees: Master of Information (which is built on the three (3) interdisciplinary graduate diplomas) and a Master of Museum Informatics and Management (name to be decided, which builds on the postgraduate equivalent). These new Master's degree programmes will be developed in coming months. The Department is currently reviewing all its graduate courses to ensure currency, relevance and the expected tripartite balance of Caribbean focus, disciplinary theory and professional competencies. It is anticipated that the Graduate Diplomas in Information Studies Programmes will be approved for offering in 2022-2023.

# <u>Graduate Research Seminars (MPhil & PhD Information Studies Candidates)</u>

As part of the revamped MPhil and PhD programmes, candidates are now required to present their research proposals at the end of their first year of registration. Each candidate presented their projects virtually to regional audiences, and fielded questions from their Supervisory Committees and general audiences. These Graduate Research Seminars introduced the professional community and student body to the expected rigor of the MPhil and PhD level of study. In so doing, these seminars promoted greater interest in the offerings of the Department and the information professions generally.

# INTERNATIONAL COLLABORATIONS AND PART-NERSHIPS

GO - opleidingen / GO - School of Information Studies (The Netherlands): Since Covid-19 GO has changed all our courses to online video-classes. Because of their online offerings they've noticed an increased interest in their courses from the Caribbean region. So far it is mainly the Dutch-speaking islands that subscribe, but more and more there are enquiries from English-speaking librarians, record managers and archivists.

During the 2019 ACURIL Conference, they had a few persons subscribe to their courses and they are in the process of organizing 'in-house' versions of their courses. However, there are a few issues that need to be resolved:

- 1. Although most of their teachers are very capable of providing their classes in English, they prefer native speakers.
- 2. The knowledge of their teachers of the local situation is limited and not all of them are flexible enough to adjust their lessons to make them relevant to the English-speaking Caribbean.
- 3. The time difference between the two regions region is troublesome for some of the teachers as it means conducting the classes always in the eve-

ning and even after midnight to accommodate the participants. The DLIS could provide some of the GO courses and can also easily deal with some of the issues mentioned above. GO is proposing that the DLIS cooperates with them to offer a program of skill enhancing courses for GLAM-professionals with a world-wide English speaking target audience.

This partnership will allow the DLIS to provide a wide range of skill enhancement courses (Continuous Professional Development [CPD]) for all DLIS-alumni and librarians all over the world. A good way to expand the DLIS portfolio. The DLIS lecturers will earn extra income, and so will the DLIS.

#### Additionally, the partnership could yield

- 1. Offer Four (4) DLIS-GO Institutes Summer, Autumn, Winter and Spring during the calendar year Joint DLIS /GO Institute courses offered in Summer, Autumn, Winter and Spring. These will be offered online to limit the effort and capacity needed, and the offerings will be structured in a manner to attract a larger target audience. Think should prove very profitable for both DLIS and GO.
- 2. Joint DLIS/GO Exhibit booth at the Association of Caribbean University, Research and Institutional Libraries (ACURIL) 2023 Conference GO will be a sponsor for next year's ACURIL conference in June 2023. Go is proposing a joint DLIS/GO exhibit booth staffed with DLIS and GO team members at the conference. All exhibit expenses will be paid by the GO school, so there is no cost to DLIS to join the exhibit.
- 3. Joint DLIS/GO Information Session at the ACURIL 2023 Conference

As an ACURIL sponsor, Go-School will organize a joint information session with DLIS (somewhere in the ACURIL program) where we could inform all ACURILEANS about the Summer Institute and upcoming joint DLIS/GO courses. In this way we could generate interest to potential participants about our combined activities. GO will volunteer to write to ACURIL about this request for organizing such an information session.

#### The University of Glasgow, (Scotland)

Professors Lorna Hughes and Ann Gow are members of the Department of Information Studies at the Glasgow-Caribbean Centre for Development Re-

search (GCCDR) at the University of Glasgow, Scotland. After establishing a Memorandum of Understanding with the UWI, they visited the UWI, Mona Campus in May, 2022, in a bid to create opportunities for collaboration and engagement with Departments/Faculties in the UWI.

In response to this partnership proposal, the Department of Library and Information Studies (DLIS) proposes to:

- 1. Coordinate/facilitate tours/extended visits to places of significance in our discipline, which will also help expose visiting students to the Jamaican culture, eg. The National Library, a museum, an archives, and the National Gallery.
- 2. Facilitate co-teaching.
- 3. Allow the programme to facilitate an overseas practicum experience for one or two DLIS/Glasgow students through student exchange arrangements.
- 4. Facilitate/guide Information Studies students, or students from other disciplines conducting research at the UWI.
- 5. Allow graduate students from both institutions to collaborate on the completion of research projects.
- 6. Include research students from the UG to make presentations in the DLIS InfoTalks sessions.
- 7. Include them in the planning and execution of DLIS research fora, special lectures.

# **DLIS 50TH Anniversary Celebration**

The Department of Library and Information Studies (DLIS) celebrated its 50th Anniversary with a Virtual Symposium on the Zoom platform. Two outstanding features of the Symposium were The Ken Ingram Lecture and the DLIS 50th Anniversary Scholarship which was awarded to one undergraduate and one postgraduate student. There were approximately twenty-nine presenters and eight panellists from countries such as Zimbabwe, USA, Aruba, Jamaica and other regions of the Caribbean.

#### **DLIS 50TH Anniversary Church Service**

DLIS commenced its 50th Anniversary celebratory activities with a church service at the Bethel Baptist Church, in Half-Way-Tree, on Sunday, November 14, 2021 at 10:00 a.m.

The DLIS 50th Anniversary Symposium took place over a three-day period, between March 29 and 31, 2022. It received special sponsorship from EBSCO Information Services, GO-School of Information, the University of Technology, OCLC and the Broadcasting Commission of Jamaica. It was well attended on all three days by participants/professionals from across the Caribbean region. The Ken Ingram Lecture was delivered by Professor Jeannette Bastian, Honorary Professorial Fellow in the DLIS on the final day of the DLIS 50th Anniversary Symposium. This was a free lecture. It was attended by more than 100 persons, and received very positive feedback. Professor James Robertson provided an overview of the Ken Ingram Lecture Series.

### **OUTREACH ACTIVITIES**

#### **Caribbean Marketing Campaign**

Between October 22 – November 25, 2021, the DLIS embarked upon an aggressive marketing campaign via Zoom, in a bid to increase student numbers in all its programmes. As such, it sought to engage library systems and LIS professional associations in CARICOM territories. The aim of those sessions was to make persons aware of the existence of the DLIS and to market and promote the programmes that it has to offer. On each occasion, the session was chaired by Mr Mark-Jeffrey Deans who is the DLIS Librarian and Fieldwork Coordinator. In addition, the welcome was given by Dr. Rosemarie Heath, Lecturer and Head of the DLIS. She also shed light on the graduate programmes offered. Dr Ruth Baker-Gardner made attendees aware of the undergraduate programmes.

Attendees were asked to register by clicking on a link that was provided in the Zoom chat. This link led them to a series of eight questions to respond to in Google Docs. Attendees were asked to supply their full name, nationality, educational qualifications, email address, telephone number (whatsapp), possible date of entry and programme of interest. Also, they were prompted to state any additional comments or questions that they wanted to be answered.

Attending the first meeting were persons from Tobago (NALIS) as well as the HEART Trust NTA. Six subsequent meetings took place between Friday, October 29, 2021 and Thursday, November 25, 2021. The reach included (from Jamaica), librarians in teachers' colleges, schools and community colleges, the Jamaica Library Service, government ministries and departments. Other participating countries include, Trinidad (NALIS), Belize, Barbados, the Cayman Islands, Guyana, the Bahamas, Dominica, British Virgin Islands, St. Lucia, Grenada, St. Kitts and Nevis, Antigua and Barbuda, and St. Vincent and the Grenadines.
