WORK OF THE CGDS MONA UNIT

The mandate of the CGDS is teaching, research and outreach/public service. The Unit met all its targets and implemented the recommendations of the OBUS Assessment, which stated that the CGDS Unit should:



- review, revise and expand courses to better respond to emerging gender and development issues;
- rationalize undergraduate courses to reduce overlaps and to ensure closer articulation between and amongst the diploma, undergraduate and postgraduate courses;
- expand research and outreach in response to emerging gender and development issues in the Caribbean.

Guest Lectures

The Unit exceeded its target of Guest lectures and responded to requests from several groups and institutions on and off campus, locally and overseas (including in the Turks and Caicos Islands). Dr Dunn also delivered the Annual Derek Gordon Memorial Lecture in the Faculty of Social Sciences Mona on January 27 2007.

The Unit completed its scheduled review and amendment of undergraduate courses offered in the Minor and plans to resubmit these to AQAC for revalidation in AY 2007/2008. Staff also participated in

curriculum review sessions hosted by the CGDS RCU. The Unit also achieved the target of expanding research and outreach.

OUTREACH

The Unit exceeded its targeted outreach programmes. The Lucille Mathurin Mair Public Lecture was held on November 29 2006 and was delivered by distinguished Guyanese Jurist Madam Justice Desirée Bernard, female Judge in the Caribbean Court of Justice.

The Conversations with Gender Series was revived and the following sessions were held:

- 'Gender Based Violence' with Justice Desirée Bernard of the Caribbean Court of Justice and Mrs Mary Clarke, Children's Advocate, Jamaica (Nov. 26 2006).
- "Mrs. Sisulu's husband: Gendered Relations in an African Marriage". A public lecture by Ms Elinor Sisulu, award winning Zimbabwean/South African writer and gender activist. (April 23, 2007). Part of a Caribbean lecture tour sponsored by SEPHIS/CGDS St Augustine Unit.
- Two stakeholder consultations were held on July 12 2006 and December 4 2006. The former guided our programme response to emerging gender and development issues. The latter included a review of the 2002 Women's Manifesto on Gender Based Violence.

Outreach included responding to requests for media interviews & articles. These resulted in increased visibility for the Unit in the print & electronic media, increased public awareness & increased discussion of gender issues.

- Teach two new Philosophy of Gender Courses
- Present revised courses for the Minor for re-certification by AQAC as well as complete and submit one new course for approval.
- Maintain research and publications with a minimum of two per year for academic staff
- Publish and launch a minimum of two (2) CGDS publications if resources allow
- Continue outreach including collaboration with Shortwood Teachers' College on a gender in education module
- Mobilise a minimum of US\$50,000 by way of Summer School income, sale of publications and consultancies.
