DEPARTMENT OF GOVERNMENT

Anthony Harriott, BA, PhD UWI – Head of Department

The Department of Government is in a process of renewal. During the year, Professor Trevor Munroe and Mr. Louis Lindsay retired after 38 and 30 years of service respectively to the UWI. In the previous year, Professor Edwin Jones retired. Over the next two years, another two members of the faculty will retire. At the end of this period, the generation that came to the UWI in the late 1960s and early 1970s after completing their advanced degrees at the best universities in the UK (in the case of Mr. Lindsay - the US) would



have made their exit. They have all distinguished themselves in various fields. Professor Jones received high national honors (the Order of Jamaica) for "excellence in academia and public service." A very successful conference was also held in his honour here at UWI, Mona.

The challenge that the Department is faced with is to ensure that the outgoing group is replaced by young members of faculty that are at least of a similar quality. During the year Dr. Jermaine McCalpin and Dr. Lloyd Waller were recruited. Dr. McCalpin comes to us from Brown University in the USA and Dr. Waller from Waikato University in New Zealand. There are a number of newly recruited Assistant Lecturers and Teaching Assistants who have either recently completed, or are at advanced stages of their MPhil or PhD programmes. In the disciplines of International Relations and Political Science, the recruitment pools are quite promising. Recruitment of new faculty in Public Policy and Public Sector Management more generally, however, presents us with some difficulty.

TEACHING

During the academic year the Department sought to broaden its course offerings, improve the quality of its teaching and to enrich the experiences of its students.

Undergraduate Matters

A total of ten students from the Department received awards for their academic achievements.

Some 142 students successfully completed the requirements for their programmes of study with 5 achieving First Class, 56 Upper Second, 75 Lower Second and 6 Passes.

Graduate Matters

The Department introduced one new

graduate course, taught by Dr. Diana Thorburn, on the Foreign Policy of the United States. This course partly fills what was an obvious gap in our course offerings in International Relations. A Parliamentary Internship Programme was launched and the first group of seven students was assigned to work with selected parliamentarians and Parliamentary Committees. This was largely the outcome of considerable effort by Professor Trevor Munroe. The programme was well received by both the students and the parliamentarians. In at least one case, the experience contributed to the development of an excellent research topic. The Department hopes to continue and expand on its internship programme for graduate students.

During 2006-07, a total of 162 students were registered in the MSc Government programme and 16 in the MPhil/PhD programme. At least 30 students completed the requirements for the M.Sc. degree by submitting their Research Papers for examination by July 31 2007. The Department takes great pride in the fact that one of its MSc students, Miss Nadiya Figueroa, was awarded the Jamaica Rhodes Scholarship for 2007 to pursue a PhD in Development Studies at Oxford University.

The graduate students, with the support of the academic and administrative staff of the department, organised a two-day research conference. The programme included presentations on recently concluded MSc Research Papers, presentations of research proposals and work in progress.

A major challenge with respect to our graduate work is to better structure the research programmes in order to improve the competence and accountability of the candidates and to ensure that they complete their programmes of study in a timely manner. Attachments to projects via the various Centres may provide a source of funding so that candidates may pursue their programmes on a full-time basis.

RESEARCH AND PUBLICATIONS

The research output of the department remains consistently above the mean output for the Faculty of Social Sciences. There were 22 refereed publications during the academic year.

These included 1 book (and another that was not referred), eight book chapters and 13 Journal articles. The mean output for the full-time tenure-track members of the Department was 1.1. In addition, some 34 papers were presented at local, regional ad international conferences. This indicates a fairly robust programme of research. This activity serves to maintain, and in some fields to improve, the profile and reputation of the University and the Department internationally.

The Professors continue to lead in this aspect of the Department's work. They account for some 20% of the full-time members of the department (Lecturer and above) and 59% of its publications and papers for the year. The professorial group contributed 62% of all conference papers, 46% of the articles, 75% of the book chapters, but none of the books. As would be expected, their contributions have not just been in the quantity of publications but also their quality. The Department received three of the four Research Day awards that were made within the Faculty. The Principal's Research Award was made to a team of authors led by Professor Stephen Vasciannie for their work on the Jamaica Human Development Report 2005.

The senior members of the Department have sought to further advance the research-oriented activity of the department via partnerships with other universities and international institutions with similar specialized interests and competences. Much of this activity takes place in the three Centres that are affiliated to the Department.

The Centres

The Department houses three Centres. These are the Centre for Leadership and Governance, the Centre for Caribbean Thought, and the CAPRI.

Leadership and Governance

This Centre was successfully launched. Its first major project was the development of an instrument for the periodic measurement of aspects of political culture in the region. On the basis of this work, the publication - Probing Jamaica's Political Culture Vol. 1 was produced. Its findings have been widely publicized and seems to have somewhat influenced the popular debates about the problems of development in Jamaica.

As noted above, an internship programme was implemented. The seven members of the first group of participants in the programme have completed their tour.

A Leadership Forum on the Knowledge Economy was staged. This was done jointly with the Mona School of Business. The Forum was hosted by His Excellency the Most Honourable Professor Kenneth Hall, ON, OJ, Governor-General of Jamaica.

Centre for Caribbean Thought

The Centre for Caribbean Thought (CCT)was launched in 2001 with a view to increase knowledge on outstanding Pan-Caribbean intellectuals and Caribbean intellectual thought. The Centre's establishment represents a culmination of initiatives for the greater institutional recognition of Caribbean Thought as a legitimate field of inquiry. The CCT has hosted "Caribbean Reasonings" Conferences from 2002.

In 2006, the Centre hosted the fifth Annual "Caribbean Reasonings" Conference in honour of Richard Hart. The theme of the conference was 'Politics, Activism and History: The Life and Times of Richard Hart'. The Centre co-hosted a three-day workshop in October 2006 on 'African and African Diasporic Knowledges' with the University of Cape Town and Brown University. In 2007 the CCT and the Department of Philosophy, UWI Mona, co-hosted the Caribbean Philosophy Association conference under the theme: "Shifting the Geography of Reason IV: Intellectual Movement".

The CCT is interdisciplinary in its focus and conscious of the need to recognize both the formal intellectual, as well as the folk philosophical

traditions. It is an open space for the development of the Caribbean philosophical tradition, conscious of the past, yet looking to the future. The CCT is headed by Brian Meeks, Rupert Lewis (Department of Government UWI, Mona) and Anthony Bogues (Department of Africana Studies, Brown University). The Centre's staff consists of Adlyn Smith-Graham, Senior Administrative Assistant and Leon Burrell, Research Assistant. Members of the Advisory Board of the CCT include Kamau Brathwaite, George Lamming, Sylvia Wynter, Ngugi wa Thiong'o, Stuart Hall, Horace Campbell, Paget Henry, Lewis Gordon, Erna Brodber and Glen Sankatsingh.

CaPRI

The period August 1 to December 31, 2006 saw the <u>Taking</u> <u>Responsibility: The Jamaican Economy Since Independence Project</u> (JEP) engaged in a series of highly publicized events. Led by Chairman, John Rapley, Executive Director, Imani Duncan and Programme Administrator Shakira Maxwell, the result of three years of work culminated in a high-quality final document, Taking Responsibility: The Jamaican Economy Since Independence, which detailed Jamaica's post-independence economic history. The JEP has focused on studying the economic history of the island - understanding the shortcomings and successes with an eye on making recommendations for the present and future direction of the economy.

The most significant achievement of the JEP at the end of 2006 was the successful staging of a public meeting on December 7, in Emancipation Park to present and discuss the findings of the project. The event saw almost 1000 people gathered in the park and included an exploration of the project's history; the preliminary findings of the Taking Responsibility Project and the announcement that a Policy Research Institute was to be formed. A second launch was subsequently executed on February 22, 2007, in Sam Sharpe Square, Montego Bay.

Following the success of the Taking Responsibility Project, the Caribbean Policy Research Institute (CaPRI), emerged on January 1st, 2007. CaPRI was created to address two information/deficits - in the general society and among policymakers, both in the private and public sector - identified in the Taking Responsibility Project. Firstly, it is to focus on breaking into the policy circles by promoting an evidence-based policy-making in the Caribbean. It also seeks to increase and develop the Caribbean's research capacity through the utilisation of the Diaspora. The Institute is managed by an Advisory Board, comprised of

members of the local private and public sector; regional public sector; and international representatives. The day-to-day activities are managed by an administrative team, led by Executive Director, Kim Marie Spence and Program Manager Shakira Maxwell. The President and Research Director John Rapley, with the support of the administrative team, currently manages the research direction and overall image of the Institute.

From June 19-21, 2007 CaPRI was represented at the "Conference of the Caribbean" in Washington DC. On the 21st of June, the IAD (Inter-American Bank) hosted CaPRI at a meeting which included members of the CSA (Caribbean Studies Association), representatives of the IMF (International Monetary Fund); the Canadian High Commission; and a number of other academic institutions. CaPRI was also represented at the "Canada Ideas Forum" from July 17-19 convened on the occasion of Canadian Prime Minister Stephen Harper's visit to the Caribbean. The CDB (Caribbean Development Bank) also hosted CaPRI as a part of its discussion series at their boardroom in Barbados.

Since February the Institute has had a monthly column in The Sunday Gleaner. The Institute has used this column, with success, from February 2007 to capture the attention to crucial issues. The Institute's policy review series was also launched during the academic year.

During the year CaPRI also secured grants from CIDA, the International Development Research Center (IDRC), the Center for International Governance Innovations (CIGI) and several members of the Jamaican private sector through strong support from the Private Sector Organization of Jamaica (PSOJ). It further launched an ambitious research agenda which included a cross-national study on changing forms of governance (the new medievalism), as well as a research programme in economics.

All of the Centres are incorporating graduate students in different aspects of their work. Their success as centres of excellence is dependent on the Department and Faculty being able to attract quality, high performance graduate students on a full-time basis and to improve their education and training.
