## OVERVIEW

The 2021-2022 academic year (AY) was a successful transition year for the Institute for Gender and Development Studies (IGDS) with a greater focus on cementing the regionality of the Institute. At the beginning of the year, Prof. Paula Morgan replaced Prof. Opal Palmer Adisa as University Director. The activities of the Institute continued to be governed by its theme of Research, Activism, Community Engagement and Education (RACE), in support of fulfilling the objectives of The UWI's Triple A Strategy. The IGDS - RCO remained guided by the IGDS' Mission "To produce and disseminate knowledge to transform gender relations in the Caribbean, in support of The University of the West Indies' (The UWI's) mission to enhance regional and international development" and its Vision of ensuring that "All UWI graduates are committed to social justice and the promotion of gender-responsive human relations and development". The IGDS - RCO staff must be commended for its hard work in successfully realising most of the established objectives in teaching, research, activism and outreach. The highlights for the AY include the significant progress made toward gender mainstreaming, including the revision of The UWI Gender Policy, the drafting of the Terms of Reference (TOR) for the Campus Gender Task Forces and The UWI Gender Sensitization Handbook, as well as work on the staff and student gender audits. Strides towards enhancement of the regionality of the IGDS were manifested in the harmonisation of two graduate courses, the hosting of an inaugural IGDS Graduate Symposium, and advances in the development of an online MSc in Gender and Development, and an increased number of regional webinars. Also, the IGDS - RCO hosted several regional webinars, including a panel discussion titled "Where have all the Women Gone? The Shift from Women to Gender in Feminist Discourse and Praxis" on March 9, 2022 in observance of International Women's Day (IWD) and the Portia Simpson Miller Annual

Lecture was delivered by Prof. Verene Shepherd, Chair, UN Committee on the Elimination of Racial Discrimination (CERD) and Director of Centre for Reparation Research, The UWI on May 12, 2022. The theme was "Get on Board Sisters! The Woman's Case for Reparatory Justice."

Other highlights include the completion of the UNESCO Caribbean Heroes Initiative summer school, which received high commendation from its sponsors. Substantial progress was also made on the US Public Diplomacy Small Grants Project and the UNDP Spotlight Initiative Caribbean Regional Programme: Strengthening Regional Cooperation to prevent and respond to family violence in the Caribbean project. During the year, the staff continued to work on individual publications and present at various fora.

## **WORK OF THE DEPARTMENT**

# ACCESS

### **TEACHING, LEARNING & STUDENT DEVELOPMENT**

The following degrees in Gender & Development Studies were offered during the AY: a post Graduate Diploma; an M.Sc., an MPhil; and a PhD. Seven graduate courses were offered via the Zoom platform and were taught by Drs. Dalea Bean, Natasha Mortley, and Imani Tafari-Ama, as well as faculty from the IGDS – Nita Barrow (NBU), St. Augustine, and Mona Units and adjunct lecturers. Prof. Paula Morgan delivered guest lectures. Nine new students were registered for the AY; six MScs, one MPhil, one PhD, and one in the Diploma programme. Twenty-one MSc and 15 MPhil students were enrolled in the combined programmes. Seven students graduated in November 2021; one with a Post-graduate Diploma; five with an MSc and one with a PhD. Two students, Cynthia Pitter and Na-deen Spence, successfully defended their dissertations.

The Institute continued to provide developmental support to its students at both the IGDS - RCO and regional levels. The regional IGDS Workshop Series for Graduate Students, implemented and spearheaded by Dr. Dalea Bean in the 2020 – 2021 AY continued to provide support to the students on various topics including Critical Reading, Writing a Literature Review, and Data Collection. Expertise was provided by the Institute's staff, as well

as regional and international partners. For the first time, a Regional IGDS Graduate Symposium comprising three panels was held on May 26, 2022 with participation from graduate students in the NBU, St. Augustine Unit (SAU), and IGDS – RCO. Additionally, one MSc seminar was held on November 16, 2021. Of note, work commenced to offer a joint online PgDip and MSc in Gender & Development Studies, with individual units operating MPhil/PhD programmes. This move is within the context of the One UWI mandate and one of the recommendations from the recently held IGDS Governance Task Force, as well as in the interest of widening the reach of the IGDS to a global community of learners.

## STUDENTS

Shenecia Brown, an MSc student became the fourth recipient of the Catherine James Scholarship. Three graduate students were shortlisted for the Iceland Erasmus scholarship. The IGDS - RCO continued to market its graduate programmes through its social media Graduate Ambassador Programme (GAP) which involves graduates in mentorship, networking and marketing etc. Promotional videos, by current and past students, were uploaded on social media. The Institute also participated in UWI Mona's "Metaverse Expo" on March 24, 2022.

## ALIGNMENT

The IGDS - RCO continued to promote activism and public advocacy

through a range of regional outreach efforts, both at the institutional and individual levels as it advanced the alignment pillar of the Triple A Strategy. Members of staff both organised and presented at public fora at the national, regional, and international levels and also made several media appearances. At The UWI, Prof. Paula Morgan chaired the Gender Mainstreaming Committee (GMC) and continued with the implementation of The UWI Gender Policy. She also led several initiatives, including the revision of The UWI Gender Policy, the drafting of the TORs for the Campus Gender Task Forces, and the UWI Gender Sensitization Handbook. The survey instruments for both the staff and student gender audits were designed and the student pilot were completed in collaboration with Dr. Halima-Sa'adia Kassim of the Planning Office, before handoff to the One UWI Gender Justice and Equity Research Committee.

## PROJECTS

The IGDS – RCO was involved in three main funded projects and signed a new contract for the continuation of the UNESCO SHEROES Initiative. Projects undertaken during this period include:

- i. UNDP Spotlight Initiative Caribbean Regional Programme: Strengthening Regional Cooperation to prevent and respond to family violence in the Caribbean Project, valued at USD 49,995.00 commenced on October 15, 2021 and is due for completion in November 2022. The IGDS – RCO was contracted to train the staff of Gender Bureaus in Belize, Grenada, Guyana, Jamaica, Trinidad and Tobago (T & T), and Haiti. During the AY, training was conducted in all of the above-named territories and also in St Lucia, and the Inception Report; the Preliminary Pre-Assessment Training Needs Report; the Gap Analysis; the draft Curriculum Design and Training Manual were completed. The principal investigator is Prof. Paula Morgan and the project manager is Mrs Carol Watson-Williams.
- ii. The US Public Diplomacy Small Grants Project valued at USD 24,000 commenced on October 15, 2021 and will be completed in August 2022. The project was aimed at implementing a dialogic island-wide performance-exhibition education campaign in Jamaica by developing a storytelling model for critically analysing gender-based violence (GBV) in Jamaica. Project outputs included two videos, a situational analysis, and a final project report. The project was led by Dr. Imani Tafari-Ama and managed by Ms. Coleen Douglas.
- iii. UNESCO Caribbean Sheroes Initiative (CSI) Phase 2 (Advocacy Train-

ing) Project, valued at USD 14,000 was completed in November 2021. The Institute conducted a five-day and a three-day training programme with approximately 64 youth advocates from Aruba, Barbados, Belize, Curaçao, Guyana, Jamaica, St. Kitts and Nevis, St. Lucia, St. Vincent and the Grenadines and T & T in Gender Equality, Advocacy and Development. Other outputs included a training and mentorship curriculum and two project reports. The Training Coordinator was Prof. Opal Palmer Adisa with project assistance provided by Ruth Howard.

- iv. USAID Positive Pathways Activity in Jamaica Project in partnership with the Peace and Love in Society (PALS) commenced in June 2022 and would be completed in August 2022. The project is aimed at implementing a community transformation-through-training (C-TTT) initiative in three Kingston communities. During the review period, training sessions were held in Jones Town, Hannah Town and Denham Town. The training focused on domestic, community, and GBV. The project lead was Prof. Paula Morgan.
- v. **New Project:** UNESCO Cluster Office Caribbean Sheroes 2022 Edition – Transforming Mentalities project valued at USD 7000. The project deliverables will include the completion of an overview of at least 20 CSOs in the Eastern Caribbean and a celebratory webinar in their honour, a Masculinities training module, and a three-day summer school.
