WORK OF THE DEPARTMENT

The most noteworthy aspects of the work of the Department during academic year 2006-07, were expanded efforts at building research capacity, expanded efforts to interact with the non-university community, particularly on the part of our students and deeper faculty involvement in efforts to enrich the student experience.

The Department continued its efforts to foster a research culture, by creating opportunities for presentations in



departmental seminars, supporting conference travel for conference presentations and organising training programmes directed at building research skills. There were also a few notable examples of outreach and networking activities arising from the efforts of individual members of the Faculty.

Research and Capacity Development

On March 6, 2007 the Department in collaboration with the Sir Arthur Lewis Institute of Social and Economic Studies and with the support of the Office of the Dean of the Faculty of Social Sciences organised a forum entitled Banking on Sustainable Development to mark the launch of Dr Jenifer Daley's first book, entitled Examining bank failure

<u>in developing countries</u>: <u>Lessons from Jamaica</u>. The forum was attended by a wide range of individuals from the financial sector.

The Department of Management Studies in association with the Department of Sociology, Psychology and Social Work hosted a 3 day Writers' workshop from July 3 - 6, 2007. The workshop was designed primarily as an introduction to the research process and was facilitated by the very experienced Professor Deborah Valentine, Director of the Colorado State University School of Social Work, outgoing Editor in Chief of the Journal of Social Work Education and Treasurer of the National Association of Deans and Directors (of Schools of Social Work) in the USA. The first day of the workshop held in Kingston focused on developing a research question and overcoming the many obstacles to research work. The residential component took the form of a 2-day retreat and was intended to give attendees the time and space to reflect on their research idea and to begin to develop it into a research paper. There were opportunities for group and individual consultation as well as opportunities for private work.

During the month of August 2006, the Department with the support of the Dean undertook exploratory research aimed at obtaining the perspective of lecturers on student performance. The process involved a number of faculty members including, Dr. Hilary Robertson-Hickling, Dr Noel Reynolds and Mrs Audrey Welds. It is expected to form the foundation for initiatives in curriculum development and for further institutional research.

Outreach

Among the key elements of the Department's outreach activities for the year under review were: faculty exchange, student mentorship and student internship.

Faculty Exchange

Dr. Jenifer Daley served as a visiting scholar at the University of Akron (UA), Akron, Ohio from June - July 2007. She taught two courses and engaged in research with faculty members of UA. On completion she received an invitation to return and to establish an exchange program for students and possibly, faculty.

Student Mentorship

The Department continues to place strong emphasis on enhancing the experience of students through quality teaching, improved administration and special programmes of mentoring. During the 2006-07 academic year, initiatives falling under the latter heading were particularly remarkable and were targeted at year groups separately.

Year 1: For the second year running, the Department welcomed first year students with a special programme themed "Taking Charge of your DOMS Experience". The programme, managed by first year coordinator, Arlene Chambers, directed students toward goal setting and self management in their academic and co-curricular activities. Throughout the year, Ms Chambers devoted considerable attention to monitoring the academic performance of the first year students and providing counselling services where this was required.

<u>Year II:</u> In October, 2006 the Level II coordinator Mr. Michael Williams organised two seminars (one for part-time and the other for full-time students) aimed at sensitising them to the challenges of advancing from year to year of their program of study and providing them with guidance in managing course load. The Deputy Dean, Mr. Stanford Moore, outlined to students the process and criteria for award of degrees and alerted them to common mistakes that can impede progress towards meeting graduation requirements.

<u>Year III:</u> In order to assist finalising students with the transition to work, Dr. Lloyd Prince (a part-time lecturer) was contracted to conduct a seminar series entitled "Career Development and The Young Professional". The Programme was held on three Thursday afternoons, two in the first semester and one in the second.

Student Internships

During this year the Department stepped up its response to the demand from both students and employers for greater student engagement in practical, job related activities during the period of their studies. Among the noteworthy activities carried out in support of this objective:

A presentation by Yolande Hylton, the 2006 recipient of the Prevista Experience, an internship awarded by the UWI Alumni Association (UK Chapter), on her summer internship experience in London. The presentation was organised by the Student Transformation Committee, which then made presentations to the top performing students in each option as a means of encouraging excellence among the student body.

A number of presentations were made showcasing internship opportunities available to students of the department both internationally and locally. These featured:

- Dr Noel Reynolds speaking on the "Caribiz/SEO Wall Street Internship Program" offered by Sponsors for Educational Opportunities (SEO) and UBS Investment House and organised by himself and Mr Archibald Campbell.
- Ms. Densie Gowdie speaking on the "Courts JUMP program" offered by Courts Jamaica Ltd.
- Mr Terry Thomas speaking on the "Department of Management Studies Internship Program" offered by the Department in association with a range of local firms and coordinated by himself, Mr Archibald Campbell and Dr Jenifer Daley.

Among the other highlights of the student internship programmes were:

- The glowing reports on the performance of two of its students, Ms Queenie Munroe and Ms Yolande Hylton who participated in international internships during the summer of 2005-06. Ms Munroe outperformed a number of candidates from US Ivy League schools and was offered a full-time job on Wall Street. Similarly, Ms Hylton's sojourn in the UK was described as "a resounding success". The organisers wrote that she "acquitted herself brilliantly in the UK and one can truly say it was a life-changing experience for her and a milestone in our development as an Alumni Assn." Both successes have led to an expansion of the respective programmes.
- DOMS' active participation in an initiative leading to a Memorandum of Understanding between Digicel and The University, to accommodate five marketing students per year for periods ranging from 3-12 months of internship.

Other co-curricular programmes

In May, a team of five students from the Department, travelled to Barbados where they competed and won in the first inauguration of the First Caribbean Case Competition. The students, Claudia Hessing, Vanessa Hemans, Tiffany Dunkley, Tanesha Siley and Calais Hayden were coached by Claire Wilson a first class honours graduate of the Department and mentored by Dr Hilary Robertson-Hickling.

There were 26 full time and 40 part time members of staff. Teaching scores for both groups were on average 4.1 and 4.0 respectively. Total per capita publications of 0.35 is still below the agreed standards. It is hoped that our investment in fostering an improved research culture will see a steady growth in this area.

For the 2007-08 academic year, the department will focus on developing and operationalizing its response to the UWI 2007-12 strategic plan. Seven task forces have been formed to work on implementation of the key areas of the University strategy identified as being central to the work of the Department. These areas are: curriculum review, building teaching skills, e-learning, research, enriching student experience, evaluation and promotion and reform of the administrative culture and processes.
