## WORK OF THE DEPARTMENT/SCHOOL

For the academic year 2016/17 the School continued to build the MSBM brand in the Business and Management segment of the higher education marketplace. I am pleased to report that over the reporting cycle, the School made significant achievements towards achieving its objectives as outlined in its strategic plan 2013–2017. Critically, a number of faculty members were engaged in research projects that led to outputs in peer-reviewed journals, books, book chapters and conference proceedings. The body of this report shows the various activities that have been achieved under this rubric. Importantly, it is critical to note that the 2nd MSBM Business and Management Conference was held at the Jamaica Pegasus, from November 9–11, 2016, under the theme, "Connecting the dots: Enterprise, entrepreneurship and sustainable development." The conference provided another outlet for the research of the faculty.

MSBM is proud of its DBA students. Seven DBA students successfully defended their doctoral theses and four DBA students, successfully defended their dissertation research proposals during the period. An undergraduate team from MSBM representing UWI, Mona, won the inaugural Caribbean Chartered Financial Analysts Research Challenge Competition which was held in Miami on March 3, 2017. Two MSBM undergraduate tourism students won the Jamaica Tourist Board and Global Travel and Tourism Partnership Case Study Research Competition and then represented Jamaica at the Research Competition and Award held in Nice, France.

MSBM is also proud of its faculty members who have gained awards, in the Principal's Research Day Awards. This is a strong recognition of the high quality of the work that these colleagues continue to do in the academe. Overall, the performance of MSBM for the academic year 2016/17 was very strong and we look forward to stronger achievements in the next academic year.
