WORK OF THE DEPARTMENT

The Department of Sociology, Psychology and Social Work in conjunction with the FSS

@60 Celebration Committee hosted the book Launch of the latest edition of the IDEAZ Journal (Volume 15) entitled "The 2020 Vision Perspective on the Rastafari Movement" This was held on Friday, April 23, 2021, 2pm-4pm. The Department congratulates Dr. Gayle on the launch of his book, Males and Tertiary Education in Jamaica; UWI Press. As the Department and the wider University adjusts to the new norm of the Covid pandemic situation, a decision from the HOD in agreement with the Dean of Faculty have mandated its administrators to work from home while engaging students and colleagues through the administrator's email system. The process so far has been working and the online teaching is progressing with minor hiccups such as, challenges with internet and computer/laptops but thankfully some students are trying their best given the circumstances. Four members of the Department were struck by COVID-19, with one having a serious episode requiring an absence or more than two months. We have been and continue to be hampered by not only the regular challenges of the pandemic, but an absence of phone lines, unstable internet access and occasional power outages.

HRD Unit

The HRD Unit has continued in its efforts to bolster its staff and students during this time of rapid change in the way in which our courses are being delivered. In this regard, we have made good on our promise to host two webinars to reinforce the mental health of our staff

and students (Saturday, 2 May 2020) and to teach them how to use the UWI's Turnitin tool (Friday, 8 May 2020). Behind the scenes, we continue to support our staff and students to complete this semester successfully and to work on revising our MSc HRD programme for future delivery online and our PhD OB programme for easier delivery when we reopen it for admissions. We are also preparing for our two courses that will be offered during the Summer Semester. We are now contemplating the feasibility of renewing our efforts to conduct some of the activities that we had planned to do in celebration of our 25-year history as a series of webinars. We have come to realise that our students are not coping well with the COVID-19 related stress and the attendant online learning. This has resulted in a number of our students requesting leave of absence (LOA) or withdrawing from our programme. In the MSW programme out of an intake of 13 students: one no show, two (2) LOA, and one (1) withdrawal. Our more than 150 (68 first year) BSc students, on the other hand, try to push through sometimes to their detriment. They are often late with assignments or worse case we get a sick leave certificate from the health centre. Many of our first-year students were expecting the full university experience of living on hall, being away from home and parents, lyming etc. Overall, our students are not coping well. The faculty and staff of the SWU remain supportive by checking in regularly by telephoning and emailing the students.

External Collaboration

The Sickle Cell Support Foundation of Jamaica (SCSFJ), led by colleague Camille Daley, was successful in its efforts to lobby the Minister of Health and Wellness, Dr. Christopher Tufton to access support for sickle cell patients through the National Health Fund's Drugserve programme. The Cabinet approved the request in February 2021, to have the approximately 5000 patients attending the Sickle Cell Unit (SCU), at the UWI Mona Campus, most of whom are poor, to access medication free or heavily subsidized at Drugserve pharmacies islandwide. Sickle cell patients attending public hospitals in other parishes were already able to access Drugserve pharmacies. The MOU between the University of Cape Coast (UCC) and the University of the West Indies, (with the Department of Sociology, Psychology and Social Work, Mona Campus, with Dr. Michael Barnett as the pivot on this side of the waters and the Centre of International Education as the pivot for the UCC), that was mentioned in last year's report, has still yet to be signed by senior management at both campuses. The Legal Counsel Departments for both universities are presently dotting the i's and crossing the t's for the document, so to speak. On reflection, the current COVID Pandemic has slowed things down immensely, but it is hopeful that the document will be signed within the course of this calendar month.

Staff Movement

The Department of Sociology, Psychology and Social Work congratulates and supports the upward movement of Dr Marina Ramkissoon as Director of HRMD. This transfer took place in May 2021 and the Head and Staff wishes her all the best on this journey. Nonetheless, this is a major sacrifice for the Department, because not only is she one of our most senior staff members, but she is one of the polyvalent individuals, whose skillset transverses ALL of the disciplines in the Department. Dr Ramkissoon's departure leaves a significant gap, which we are attempting to underfill. Nonetheless, replacing her has not been easy and is still a work in progress as the repercussions are felt across the entire Department and indeed the Faculty.

Academic Achievement and Staff Development

Arna Elliott Rattray was promoted to lecturer, on August 1, 2020. Dr Julian Devonish proceeded on Sabbatical Leave and the Department welcomed back Dr Sharon Priestley from hers.

• Dr Gayle hosted Daddy Matters, celebrating 30 years of public service of Fathers Incorporated, an outreach of the Department of Sociology, Psychology and Social Work, on June 19, 2021. School Engagement

Dr Orville Beckford was part of the UWI Admission and Outreach Team that visits

Dr Orville Beckford organized and presented free online workshops in CAPE Sociology, Management of Business and Caribbean Studies, at UWI for high schools students. This is in an effort to improve the quality of students coming into the sociology and other programmes at UWI Mona.

ACCESS

STUDENTS

The MSc HRD programme welcomed 50 new students into its Cohort XXIII; however by the end of the semester only 44 of these persons remained to do examinations in December. These persons were joined by one student seeking courses for completion of the MSc Applied Psychology. Two persons registered in the Postgraduate Diploma in Human Resource Development and one Specially Admitted Student. The Unit continues to work on transforming its face-to-face programme to an online offering. It has worked on this process with the help of The UWI's Office of Online Learning and more recently under the auspices of the Faculty of Social Sciences. Given the continuing effects of the COVID-19 pandemic on the students the Unit hosted several webinars aimed at improving students' understanding of their discipline as well as to strengthen their ability to cope with the prevailing global conditions. The plethora of presentations included two with Dr. Schontal Moore to explain to staff and students how to use Blackboard Collaborate and OurVLE; one with the staff of the library, Dr. Alicia Palmer and Ms. Yolanda Tugwell -Turnitin Explained for Lecturers and Students; and one with Lecturer, Mr. Michael Roofe, on How to Create a Personal Budget. Finally, the Unit has embarked upon a joint project with the local clubs in Toastmasters International to place current and former students in Toastmasters clubs. The aim of this project is to upgrade the presentation and leadership skills of all students and graduate students from the MSc HRD, Postgraduate HRD and PhD Organisational Behaviour programmes.

Prizes awarded

Of the 39 students who graduated in January 2021, 21 graduated with Distinction from the 21st Cohort of the MSc Human Resource Development programme while the sole graduate from the Postgraduate Diploma programme did so with Distinction also. These persons were recognised at the annual Faculty of Social Science Awards Ceremony that was held on 21 January 2021. Additionally, the special prize winners Jillian Gordon, Shawna Symister, Jodiana Clarke and Tasharna Thompson-Henny made presentations in the Unit's annual HRD Practicum Showcase on Friday, 29 January 2021.
